

Model schedule for collaborative Hybrid joint inspection

The purpose of the model is to illustrate the possible presence and activities of the on-site and remote inspector during each day of the inspection.

This model of joint inspection schedule takes into consideration time differences of up to 6 hours between the manufacturers local time and remote inspectorate local time.

The model may be used by the on-site inspectorate to present an overall inspection plan to the manufacturer.
